- Homes should be maintained properly, including repairs and paint updated in a tasteful manner.
- Building permits are required for any additions. Permits are also required for tree removal
- Satellite dish must contact the Association Office.
- Mailboxes need to contact the Association office.
- Cars should not be parked on the grass or street, nor should an excessive number of cars be parked on property on a permanent basis. Also, boats, trailers, campers, etc. are not to be parked on the property because they are unsightly per the covenants.
- Obey the posted speed limits and absolutely no passing on the boulevard.
- Remember only an 18in x 24in real estate sign is allowed to be put on your property.
